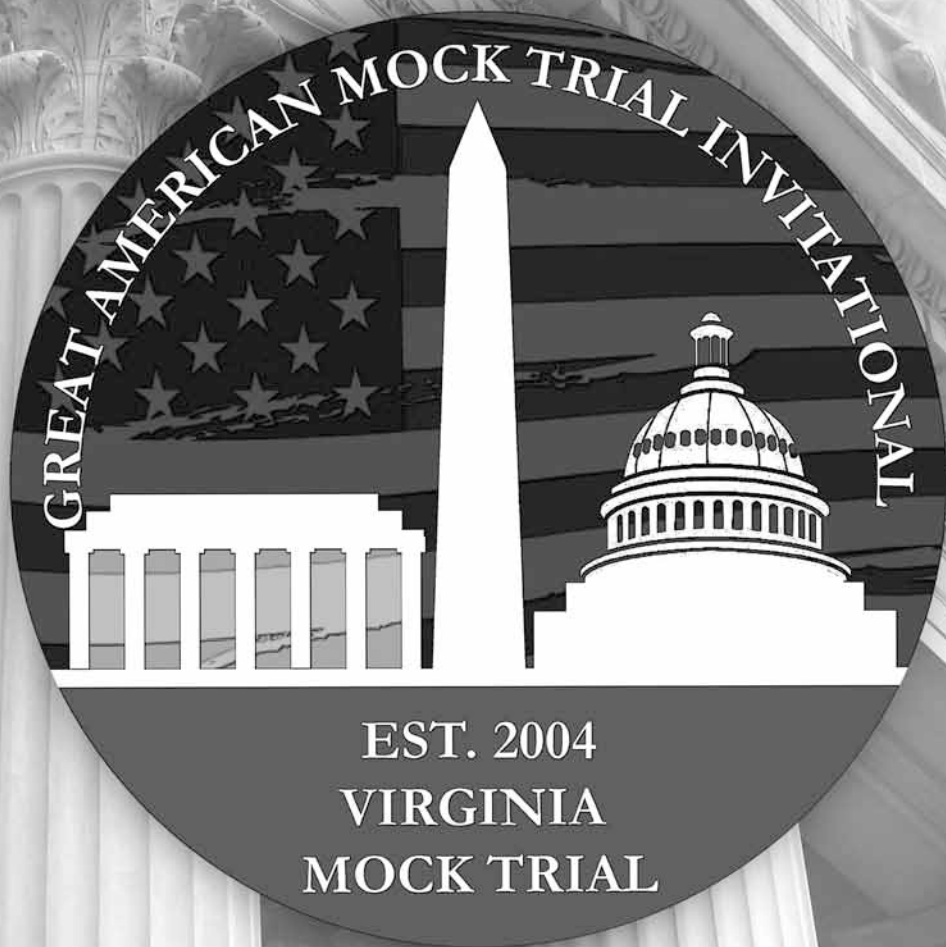

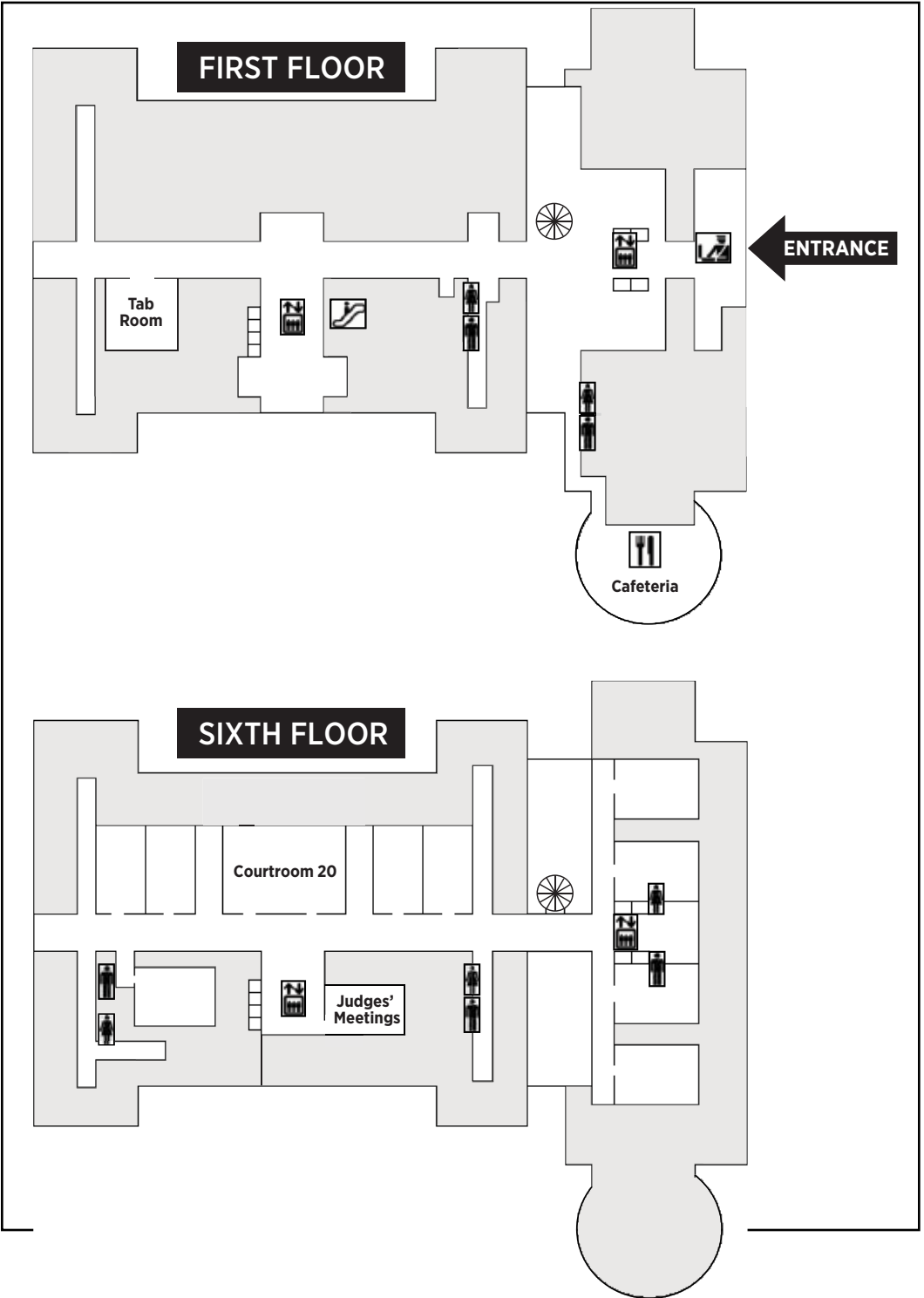
CHALLENGE ORDER

The challenged team will pick its side, but the Virginia teams will defer their selection to the results of a coin toss. You are not allowed to "pass."

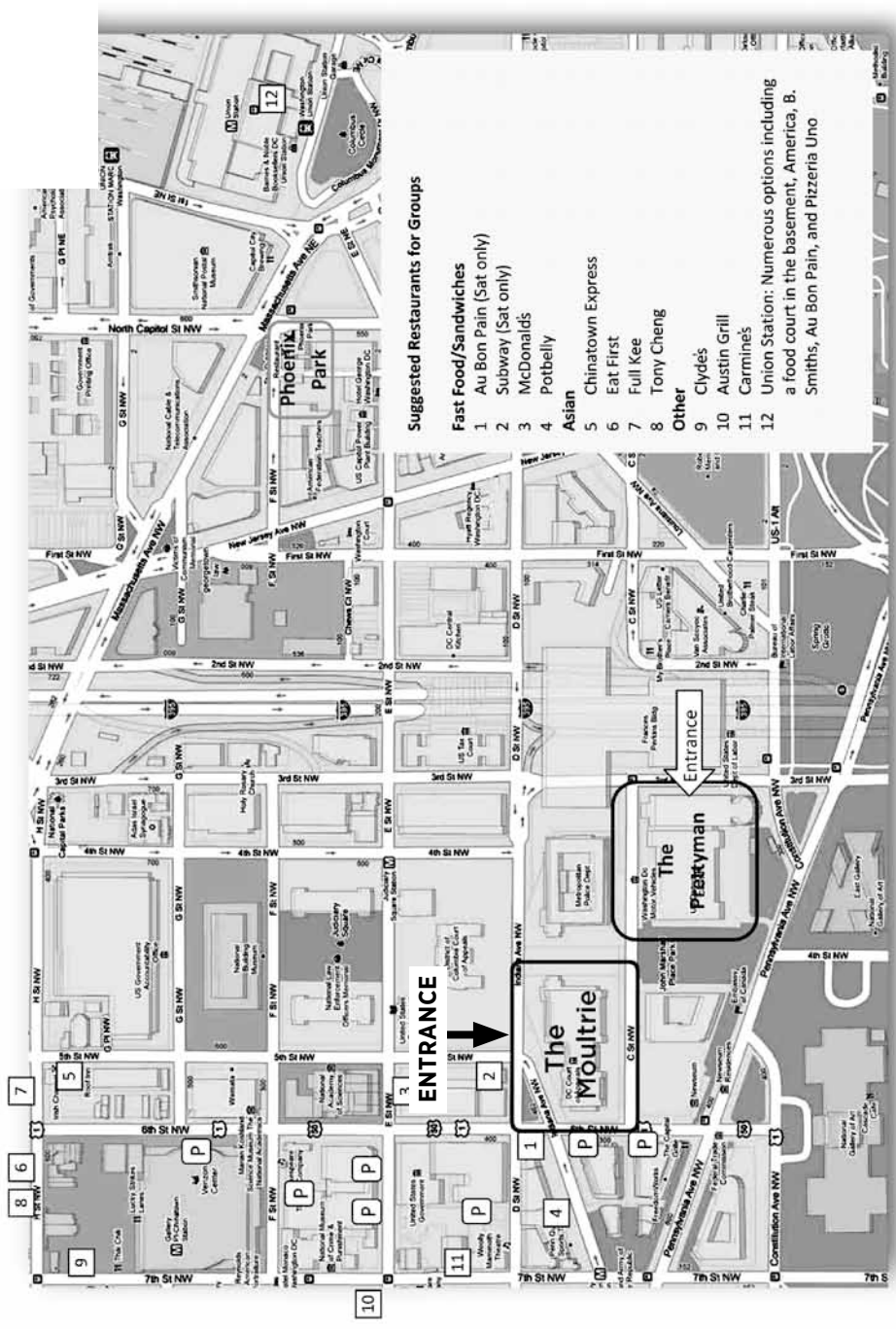
