Washington Suites Alexandria



The Washington Suites offer spacious accommodations across the Potomac River in Virginia, but convenient to downtown Washington DC.

The Washington Suites building was previously an apartment complex, and it shows in the size of the rooms. All suites feature a kitchen and separate living rooms and sleeping areas.

If you need space to scrimmage, they also have a business center and several conference rooms on-site.

The group rate is not available on their website, so please make reservations by phone or fax. If making reservations by phone, be sure to mention UVA Mock Trial to secure the group rate. If submitting your request by fax, please use the form at the back of this packet.

The location of this hotel is very convenient to the Reagan Airport and to highways into DC, but you will need a car to travel back and forth to the courthouse. On-site parking is free.

From Washington Dulles Airport - 26.5 miles (40 minutes)

- Turn left out of the rental car area going towards the terminal
- Turn left at Rudder Road and follow the signs to "Airport Exit"
- As you exit the airport, move to the left and follow the signs that say "To 495 / Washington" to the center, non-toll lanes. (12 miles)
- Take Exit 18 onto I-495 S towards Richmond/Alexandria. (10 miles)
- Take Exit 57B onto I-395 North. (3 miles)
- Take Exit 3A (Duke Street) and merge onto Duke Street. (~1 mile)
- Turn right onto S. Reynolds Street. The hotel will be almost immediately on the left.

From Ronald Reagan Airport- 10 miles (15 minutes)

- Take the signs for "Airport Exit" and follow the signs for the GW Parkway going North towards Washington. (~1 mile)
- Exit onto I-395 going South towards Richmond. (7 miles)
- Take Exit 3A (Duke Street) and merge onto Duke Street. (1 mile)
- Turn right onto S. Reynolds Street. The hotel will be almost immediately on the left.

From the Hotel to the Courthouse - 10 miles (15 minutes)

- Turn right out of the parking area onto S. Reynolds Street.
- Turn left at the light onto Duke Street (0.5 miles)
- Bear right into the I-395 N ramp to Washington, D.C. (10 minutes)
- When you reach the bridge to DC, stay to the right and on I-395 (not US-1). Move 1-2 lanes to the left.
- After passing several exits, take the right exit marked "395 N/ D Street NW / US Senate"
- When the road splits, stay in the right lane. You will then merge with a road coming in from the right and enter a tunnel. Move quickly to the right.
- Within the tunnel, there will be a right exit (Exit 9) with smallish signs that say "U.S. Capitol" and then "U.S. Senate." Take the exit, but stay in the lane that is second from the right so that you exit towards D Street rather than veering off sharply to the right.
- Immediately as you exit the tunnel, you will come to a stop light at D Street. Turn left.
- Take the next left onto Third Street. You will drive under a building that spans over the road.
- The courthouse will be on your right on the next block.

DC Hotel Options

A note of explanation: We originally contracted with a downtown DC hotel we have used several times before. Unfortunately, that hotel is undergoing renovations and we learned recently that it will not be re-opening in time for the ORCS. We have been working to find new options close to the courthouse and finally have contracts in hand. Although we do not have the time to give them the loving write-ups they deserve, we hope you will find them acceptable options if you wish to stay in DC itself. All rates do not include any parking charges that may apply and are subject to DC's 14.5% hotel tax. We have a limited number of rooms at each hotel, which will be sold on a first-come, first-serve basis

The Phoenix Park Hotel

The affordable Irish-themed hotel is located on Capitol Hill, just steps from Union Station and scores of restaurants. Distance from the Prettyman Courthouse: .6 miles.
